SEWER SERVICE AGREEMENT**

AGREEMENT is made this _____ day of 20____, between the Guadalupe-Blanco River Authority, (hereinafter called GBRA) and _____, a customer of the Guadalupe-Blanco River Authority, (hereinafter called "Customer")

GBRA agrees to provide sewer service to Customer, and Customer agrees to purchase service from GBRA at the location described above, in accordance with rules and regulations established by the Board of Directors of GBRA.

Customer shall pay GBRA for service hereunder, at the rates and upon the terms and conditions set forth in the rate schedule adopted from time to time by GBRA's Board of Directors and North Hays County Municipal Utility District No. 1. (the "District")

All charges billed are due and payable on or before the fifteenth day of each month. A penalty in the amount of 10% of the existing unpaid balance is assessed on each delinquent account. As of this date, the rate schedule is:

Customer shall install, at its own expense, a service line from the GBRA sewer collection line to the point of use. Inspection must be made by GBRA during construction, or Customer may be required to uncover the connection.

Customer shall hold GBRA harmless from any and all claims or demands from damage to real or personal property occurring from subscription for services under this agreement. Customer agrees to grant to GBRA an easement of right-of-way for the purpose of inspecting, repairing, or replacing service lines as deemed necessary by GBRA.

Based on terms of the October 31, 2005 billing agreement between Goforth Special Utility District (Goforth) and GBRA, failure of Customer to pay all charges due to GBRA shall authorize Goforth to terminate water utility service to Customer as deemed appropriate by Goforth in accordance with the procedure specified in applicable law and the water tariff and service regulations of Goforth then in effect. In the event water service is disconnected for nonpayment of sewer service charges, Goforth will not reinstate water service to Customer until Goforth receives payment of all delinquent sewer charges, plus any applicable late charges.

Billings for sewer service may be paid personally at the offices of Goforth Special Utility District, located at 8900 Niederwald Strasse, Texas, 78640 or by mail to the same address.
